## **SYPHILIS PERFORMANCE PANEL (NIB-SYPHILIS-01/2017)**

### **INTENDED USE**

The Syphilis Performance Panel No. 01/2017 is intended for use by the Indigenous diagnostic manufacturers for Strengthening of their quality and not to be used for routine diagnostic procedure / quality control evaluation / testing or any other purpose.

### **PRODUCT DESCRIPTION**

SYPHILIS Panel No. 01/2017 consists of 25 Reactive and 25 Non-reactive plasma members in 500 µl quantity. This performance panel members are undiluted, naturally occurring plasma specimens without any preservatives. The plasma members are characterized by using commercially available Rapid, ELISA, CLIA and Confirmatory Test Kits. The tests are performed at NIB by individuals who routinely use these test procedures .

### **STORAGE**

Panel members should be stored frozen at -20°C or below. Repeated freeze-thaw cycles should be avoided.

### **PRECAUTIONS**

Biohazard caution: The panel should be handled as potentially infectious material. Follow universal precautions. Negative results do not ensure the absence of these or other human pathogens. The material should be disposed OFF in a manner that will inactivate pathogenic agents according to the Bio Medical Waste Management Rules, 2016.

### **INTENDED USERS AND CONDITIONS FOR SUPPLY**

The panel will be provided to Indigenous licensed manufacturers of the Syphilis kits by submitting the following documents:

Valid License for manufacture.

Information on the number of batches produced in the last three years.

Number of Kits produced per batch.

An undertaking will have to be given by the manufacturer that the panel will be used only for the purpose for which it has been provided.
