- II. Taxes:-GST/IGST etc should clearly be mentioned on quotation.
- III. **Custom Duty:** NIB will provide necessary certificate as NIB is registered with DSIR for the purpose of availing Custom Duty exemption in terms of Government Notification No.51/96-Customs dated 23rd July, 1996, Notfn.
