2. Fall Clause Certificate: To be submitted as per format enclosed (Annexure I).
3. The bids/offers will be opened on due date of opening of bids .
4. Customer reference list for the similar items materials for last three years.
5. COA is necessary to be submitted.
6. The quotation should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not the quotation will not be considered. Quotation written in pencil will not be considered.
7. Technical details like literature, Catalogue and specification etc should be attached along with offer.
8. The resultant contract will be interpreted under Indian laws.
9. If the lowest acceptable bidder against ad-hoc requirement is not in a position to supply the full quantity required, the remaining quantity, as far as possible, be ordered from the next higher responsive bidder at the rates offered by the lowest responsive bidder.
10. Bidders will not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
11. The Institute reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
12. Manufacturer's name and country of origin of materials offered must be clearly specified. Please quote whether your organization is large scale industry or small scale industry. If you have valid NSIC/MSME/SSI/DGS&D Certificate etc. for supply of Tender's items, so please attach it to the quotation. Mention your registration details
13. Complete details and ISI specification if any must accompany the quotation. Make/brand of the item shall be stated wherever applicable. If you have got any counter offer as suitable to the material required by us, the same may be shown separately.
14. All supplies are subject to inspection and approval before acceptance. Manufacturer/ supplier warranty certificates and manufacturer/Government approved lab test certificate shall be furnished along with the supply, wherever applicable.
15. The Institute reserves the right to modify the quantity specified in this enquiry.
