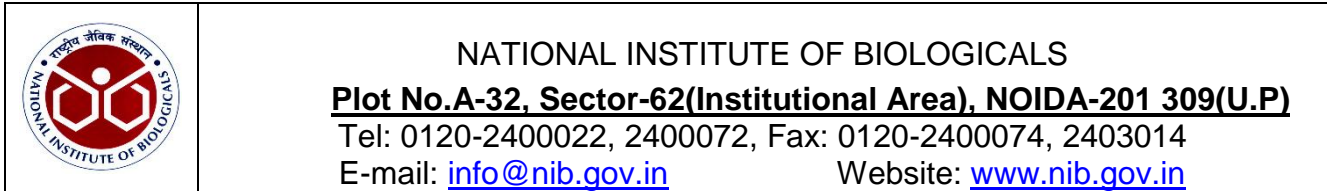

**Name of Work:** Repairing/ rewinding motors for HVAC System at NIB Noida regarding.

**1. Introduction:**

The National Institute of Biologicals (NIB), Noida, invites sealed quotations from the experienced contractors for “**Repairing/ rewinding motors for HVAC System**” at NIB Noida regarding. The bidders are advised to visit the site to see the motors in which rewinding will be done before quoting their rates.

**2. Scope of Work:**

The scope of work includes Repair, replacement of new bearings (SKF make) & rewinding of Motors, 3Phase, 415V Induction Motors (different capacity) as listed in **Price Schedule**. All petty works & changing of nuts & bolts to be done by vendor. The motors are to be collected from NIB for repair at vendor’s site. After repairing, vendor will have to return the motor to NIB, Noida & the vendor will use standard NIB’s gate pass for the same. **The winding of motors should be made by copper wire & BIS/Atlas/Milan make only.** All replaced old bearings are to be returned to NIB as a proof of replacement.

**3. Time of Completion:**

The work shall be completed within 20 (*Twenty*) **days** from the date of issue of work order/gate pass.

**4. Security Deposit:**

A sum equivalent to 10% of the contract value shall be deducted as security deposit from the bills of the vender, which shall be returned after successful completion of the Defect Liability Period.

**5. Liquidated Damages/ Penalty for Delay:**

If the contractor fails to complete the work within the stipulated time or time extended by the Institute (if any), liquidated damages at the rate of 1% per week or part thereof delay subject to maximum 10% of the total contract value shall be deducted /recovered from the contractor on reasonable grounds.

**5. Defect Liability Period:**

Repair & Rewinding of Motors shall be under 06 (Six) months **Defect Liability Period (DLP)**. Defect/s noticed during the Defect Liability period shall be rectified by the contractor without any cost to NIB, failing which the Security Deposit of the Contractor shall be forfeited. In such event the contractor may also be debarred from any future tendering in the Institute

**6. Payment:**

Payment will be made after completion of work and submission of bill by the Vendor. Taxes as applicable shall be deducted from the bill while making payment to the contractor.

**7. Bill of Quantity:**

The quantities given in the quotation are approximate quantities. Payment shall be made as per the actual work done at site.

**8. Tools & Tackles:**

- a) All tools, tackles will be arranged by the contractor and no extra payment shall be made for the same.
- b) Water & Electricity: Water & Electricity for carrying out the works will be provided by NIB at one point near the site free of cost.

**9. Purchaser`s right to vary quantities at time of award of contract:**

The Institute reserves the right at the time of contract award to increase or decrease by up to 25 % the quantity of goods and services of originally specified in the schedule of requirements without any change in unit price or other terms and conditions.

**10.** The Institute reserves the right to split the work on basis of economy in cost of work.

**10. Right to accept or reject the Quotations:**

Director NIB reserves the right to accept or reject any or all the Quotations without assigning any reason thereof.
