The tendering firm shall have to attach all the relevant documents with the tender application, failing which tender will be rejected. In case the date of opening of tender is declared holiday, tender shall be opened in next working day, but tender box will be sealed on schedule date and time.

TERMS & CONDITIONS

1. The web based applications will be hosted at NIC server after Security audit, so the security audit certificate should be in compliance with the NIC standards.
2. The vendor has to provide the separate Audit Certificate and Security Assessment Report on completion of Security Audit of "Haemo-Vigil" and "Donor-Vigil" web based application.
3. The envelope shall be prominently marked on top with "**Tender for Security Audit of Haemo-Vigil and Donor-Vigil web based application**". The envelope should be properly sealed.
4. Bid Security / EMD in the form of Demand Draft/Banker Cheque for **Rs. 5,000/-** may also be submitted along with tender. Bid Security/ EMD of unsuccessful bidders will be returned immediately after award of work. Bid Security/EMD of successful bidder will be refunded after satisfactory completion of the assigned work.
5. The tender should reach this office by **on 02.03.2017 at 3.00 PM.**
6. The offer should be valid for 120 days from the date of opening of bid.
7. Only those organizations/firms registered with the CERT-in-empanelled are eligible for submitting the tender.
8. Incomplete or conditional tender will not be entertained.
9. No tender will be accepted by hand and tender received after closing date and time, will not be entertained.
10. The first round of security audit report should be submitted to NIB within 10 working days after the work order issued by NIB and consecutive round report if any should be submitted within 5 working days.
11. If there is any delay after given time period, a Liquidate Damage (LD) @ 2% of total cost of work per week or part thereof subject to maximum 10% of the total wok value will be deducted from the bill.
12. The tenderer can remain present himself /herself or his/her authorized representative at the time of opening the tender.
13. All the firms/organization participating in the Tender must submit a list of their owners/partners etc. along with their contact numbers and a Certificate to the effect that the firm/organization is neither blacklisted by any Govt. Department nor any Criminal Case is registered against the firm or its owner or partners anywhere in India be attached with this tender. Any firm/organization blacklisted by a Govt./Semi Govt. Deptt. shall not be considered for this tender and tender will be rejected straightway.
14. NIB reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
15. The payment will be made only after submitting the Web Application Audit Certificate and Security Assessment Report on completion of Security Audit of both the web based applications. No advance payment will be made. Payment will be released after deduction of TDS and other statutory dues as applicable within 30 days after receipt of bill.
16. No claim for interest in case of delayed payment will be entertained by the Division.
17. A copy of terms & conditions attached as **Annexure-I** and Scope of work attached as **Annexure-II** duly signed by the tenderer, as a token of acceptance of the same should be attached along-with the tender.
18. All disputes are subject to the jurisdiction of the Courts in the Delhi / Noida.
19. If the firm/organization wants to know about the size, i.e. of the web application before submitting the tender, they can contact to Computer Officer, IT Cell, NIB, Noida, on all working days between 10.00 AM to 5.00 PM.
20. Firms/organization will also have to assist in fixing vulnerabilities, if any, after security audit for the platforms i.e. JAVA /Postgres SQL server at application level.

Scope of Work for the Security Audit

Primary objective of the security audit exercise is to identify major vulnerabilities of the (i) Haemo-Vigil and (ii) Donor-Vigil web based application from internal and external threats. Once the threats are identified and reported, the auditors should also suggest possible remedies. The exercise should also undertake a review of the Information security policy document and suggest additions and deletions in the light of the implementation of Haemo-Vigil and Donor-Vigil web based applications.

To ensure that the web based applications are free from the above vulnerabilities, the audit exercise will need to undertake the following activities:

1. Identify the security vulnerabilities, which may be discovered during the security audit including cross-site scripting, Broken links /Weak session management, Buffer Overflows, Forceful browsing, Form/ hidden field manipulation, Command injection,

- Insecure use of cryptography, Cookie posing, SQL injection, Server miss-configuration, Well known platform vulnerabilities, Errors triggering sensitive information, leak etc.
2. Application Security Assessment (manually and with multiple automated tools).
 3. Validation and deliverables (POC, Screenshots, attack vector, attack details in reporting template).
 4. Closing meeting
 5. Identification and prioritization of various risks to the Haemo-Vigil and Donor-Vigil web based application;
 6. Identify remedial solutions and recommendations for making the web application secure & safe.
 7. Undertake user profiling and suggest specific access methodologies and privileges for each category of the users identified.
 8. Assistance to development team in fixing the vulnerabilities.

The auditors will have to carry out an assessment of the vulnerabilities, threats and risks that exist in applications through Internet Vulnerability Assessment and Penetration Testing. This will include identifying remedial solutions and recommendations for implementations of the same to mitigate all identified risks, with the objective of enhancing the security of the system. The bidder will also be expected to propose a risk mitigation strategy as well as give specific recommendations to tackle the residual risks emerging out of identified vulnerabilities assessment. Both the applications should be audited as per the CERT-in Standards. The auditor is expected to submit the Web Application Audit Certificate and Security Assessment Report after the remedies / recommendations are implemented and confirmed with retest.

After the report is submitted by the auditors, IT Team of IT Cell of the Institute will be expected to remove all the vulnerabilities. The Audit Firm/company has to submit a summary compliance report at the end of the assessment phase and the final Report will certify that both the applications i.e., “Haemo-Vigil” and “Donor-Vigil” are developed in compliance with the NIC standards.

Deliverables and Audit Reports

The successful bidder will be required to submit the following documents in printed format after the Security Audit:

- (i) A detailed report with security status and discovered vulnerabilities weakness and mis-configurations with associated risk levels and recommended actions for risk mitigations.
- (ii) Summary and detailed reports on security risk, vulnerabilities and audit with the necessary counter measures and recommended corrective actions to be undertaken by IT Cell of the Institute.

- (iii) The Final Security Audit Certificate for “**Haemo-Vigil**” and “**Donor-Vigil**” web bases application should be in compliance with the NIC standards.
- (iv) All deliverables shall be in English language and in A4 size format.
- (v) The vendor will be required to submit the deliverables as per terms and conditions of this document.
