Invitation to Tenders Enquiry for “Painting of Stainless Steel pipe line in Service Corridors and providing covers to drain points in NIB Laboratory Building” at Noida.

1. Introduction:

“National Institute of Biologicals (NIB) is an autonomous institution under the Ministry of Health & Family Welfare, Government of India, established on 27th January, 1992 and is to be the Central Drugs Laboratory for quality control of all indigenously produced and imported biological products. Presently, five laboratories of the Institute are notified as Central Drugs Laboratory under provision of Drugs & Cosmetics Act and Rules. Institute plays a vital role in collaboration with CDSCO to strengthen the regulation of biologicals in India by averting the Not of Standard Quality Biologicals reaching the consumer, thereby promoting and protecting public health.”

2. Scope of Work:

Stainless Steel Piping network of varying diameters generally 1” to 2” dia and its support structure are to be painted with enamel paint as per the existing colour codes (Green, Blue, Yellow etc.) after removing dust, dirt, rust etc. from its surface. The work is to be carried out in four- five days’ time. The paint shall be of reputed brands and got approved by NIB.

Due care shall be taken by the contractor to prevent spillage, stains of paint on the wall/ floor etc. All spillage, stains of paint shall be cleaned off by the contractor after completion of the work. All materials, tools & plants for carrying out the work shall be provided by the contractor. Drain inspection chambers in the floor/ ceiling are to be covered with steel/ aluminum plate hinged cover and frame to give it neat finish.

3. Earnest Money Deposit (EMD):

The Bidder shall furnish EMD of **Rs. 1,500/-** (*One thousand five hundred only*) along with the tender in the shape of demand draft in favour of “**National Institute of Biologicals**” payable at **Noida**. EMD shall be returned to the unsuccessful bidders after award of work. EMD of successful bidder shall be adjusted in the security deposit. The tender not accompanied with EMD shall be rejected.

4. Security Deposit:

A sum equivalent to 10% of the contract value shall be deducted from the bills of the contractor, which shall be returned after successful completion of the Maintenance Period of 2 (two) month.

5. Maintenance Period:

The work done by the contractor shall be under minimum **two month's** maintenance period. Any defect in material / workmanship noticed during the maintenance period shall be rectified by the contractor without any cost to NIB, failing which the Security Deposit of the Contractor shall be forfeited. The contractor may also be debarred from any future tendering in the Institute.

6. Submission of Tender:

The contractor shall submit the tender in the sealed envelope in the following manner.

Envelope No. 1 - shall contain EMD in the form of bank draft for **Rs. 1,500/-** (*One thousand five hundred only*) along with a copy of tenders document duly signed and stamped by the bidder as a token of acceptance of terms & conditions.

Envelope No. 2 - Shall contain Pric-Bid (Price part only). Price shall be filled by the bidder only in the format given by NIB with the Notice Inviting tenders. Price on any other format shall be rejected.

Both the sealed envelopes No. 1 & 2 shall be then put in a bigger envelope duly addressed to "Director, National Institute of Biologicals, A-32, Sector - 62, Noida - 201 309" and marked on top tender for "**Painting of Stainless Steel pipe line in Service Corridors and providing covers to drain points in NIB Laboratory Building**" at **Noida**.

7. Time of Completion:

The work shall be completed within 1 (*One*) *week* from issue of work order.

8. Liquidated Damages/ Penalty for Delay:

If the contractor fails to complete the work within the stipulated time allowed by the Institute, liquidated damages at the rate of 10% of the total work value value shall be deducted / recovered from the contractor.

9. Specification:

The materials shall be of good quality and reputed make in the industry. The work shall be carried out as per relevant CPWD specifications and good engineering practices.

10. Payment:

Payment of the contracted price for respective item will be made on receipt of bill & inspection of site. Final payment will be made within 15 (*Fifteen*) days after completion of the work. No advance payment shall be made to start the work. TDS will be deducted as per rules.

11. Bill of Quantity:

The quantities given in the Price-Bid are approximate quantities. Payment shall be made as per the measurement of actual work done at site.

12. Tools & Tackles:

All tools, tackles such as ladders, brushes, platforms etc. will be arranged by the contractor and no extra payment shall be made for the same.

13. Risks:

Contractor shall be solely responsible for safety of his workers, working at site by taking insurance cover and following safety norms in the trade.

All risks of loss or damage to physical property and of personal injury and death which arise during and in consequence of the performance of the Contract other than the excepted risks are the responsibility of the Contractor. Excepted Risks are:

- a.
 - (i) war, hostilities (whether war be declared or not), invasion, act of foreign enemies.
 - (ii) rebellion, revolution, insurrection, or military or usurped power, or civil war,
 - (iii) ionising radiations, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosive, or other hazardous properties of any explosive nuclear assembly or nuclear component thereof.
 - (iv) pressure waves caused by aircraft or other aerial devices traveling at sonic or supersonic speed.
- b. loss or damage due to the use or occupation by the Employer of any section or part of the Permanent Works, except as may be provided for in the Contract.

- c. loss or damage to the extent that it is due to the design of the Works, other than any part of the design provided by the Contractor or for which the Contractor is responsible.

14. Disputes:

If any dispute or difference of any kind, whatsoever, shall arise between NIB and the Contractor, in connection with or arising out of the Contract, or the execution of the works, whether during the progress of the works or after their completion and whether before or after the termination, abandonment or breach of the contract, it shall, be settled under the Indian Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. Such arbitration shall be settled by Sole arbitrator who shall be appointed by Director, NIB. The arbitration shall take place in Noida/ Delhi unless both parties agree otherwise.

15. Right to accept or reject the Tender:

Director, NIB reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
