9. **Authorization of Principal:** The offer must accompanying with valid authorization certificate of principal and COA.


General Conditions.

1. Copies of the latest purchase order received from other Govt. institutions for these items may please be enclosed.
2. Fall Clause Certificate: To submit as per format enclosed (Annexure I).
3. Offer to be given by authorized dealer / distributor should have the valid authorization certificate given by the principal and it should be enclosed with Technical Bid. Please note that your offer will not be entertained without the authorization & the same will be summarily rejected.
4. **The offer should be submitted in two sets, one 'Technical Bid' and second 'Price Bid'.**
 - a. **First set should have in a separate sealed cover containing a copy of this Tender Document duly signed and stamped, Technical details like Literature, Catalogue, and Specification etc.**
 - b. **Second set should have in a separate sealed cover containing Price schedule, mentioning the discount and GST etc. Fall Clause certificate, price list and copy of earlier supply order may be retained in price bid.**
 - c. **The 'Technical-Bid & Price Bid' should be in a single sealed cover clearly indicating the name of documents, Tender No. & Due Date of opening on the sealed cover.**
5. Customer reference list for the similar items materials for last three years.
6. Indian agents, who desire to quote directly on behalf of their foreign principals must be enlisted themselves with the Central Purchase Organization (eg. DGS&D). However, such enlistment is not equivalent to general registration of supplier with DGS&D.
7. **COA is necessary to be submitted.**
8. Unsolicited bids will not be accepted.
9. The quotation should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not the quotation will not be considered. Quotation written in pencil will not be considered.
10. If a firm quotes NIL charges / consideration, the bid shall be treated as unresponsive and will not be considered.
11. The resultant contract will be interpreted under Indian laws.
12. **A bidder shall be debarred for minimum 1 year to maximum 3 years to participate in procurement process if he has been convicted of an offence under the prevention of Corruption Act, 1988; or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.**
13. If the lowest acceptable bidder against ad-hoc requirement is not in a position to supply the full quantity required, the remaining quantity, as far as possible, be ordered from the next higher responsive bidder at the rates offered by the lowest responsive bidder.
14. Bidders will not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
15. The Institute reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.

16. Manufacturer's name and country of origin of materials offered must be clearly specified. Please quote whether your organization is large scale industry or small scale industry. If you have valid NSIC/MSME/SSI/DGS&D Certificate etc. for supply of Tender's items, so please attach it to the quotation. Mention your registration details. **Note:- if NSIC/MSME/SSI Certificate not found valid and relevant, then the bid will not be accepted for exemption of EMD.**
17. Complete details and ISI specification if any must accompany the quotation. Make/brand of the item shall be stated wherever applicable. If you have got any counter offer as suitable to the material required by us, the same may be shown separately.
18. All supplies are subject to inspection and approval before acceptance. Manufacturer/ supplier warranty certificates and manufacturer/Government approved lab test certificate shall be furnished along with the supply, wherever applicable.

**NATIONAL INSTITUTE OF BIOLOGICALS
ANIMAL FACILITY**

Technical Specification for Animal Health Monitoring ELISA kits

1. The kits must be based on Enzyme- Linked Immunosorbent Assay (ELISA) and it should be able to detect IgG antibody activity specific for antigen of concern animal virus or bacteria.
2. The kits should be easy to use and requiring one protocol for all assays.
3. All incubation steps should be required to be done at room temperature (20-26°C).
4. Each kit preferably should be specific to single particular virus or bacteria.
5. Each kit preferably should have 96 wells and it might also be having the provision of removal of unused strips so that they can be used later when required.
6. The kit antigens should be free from impurities and natural circulating antibodies (such as those circulating against blood group materials).
7. It should have consistent performance in stability testing at 4°C and 37°C.
8. The kits should be reliable and produced highly reproducible results i.e. CVs <5%.
9. The kits must be requiring small sample size for testing (5 µl/ assay).
10. The kits should be compatible with plate washers, plate readers and ready to use with controls, diluent, conjugate and substrate.
11. The kits must be highly sensitive and capable to detect the low level of antibody for early identification of infection.
12. The kits should have shelf life of 18 months at least.
13. The kits must have an option of customization to meet specific testing needs.
14. All calculations required to quantify antibodies in samples should be very clearly explained well in detail.
15. Detailed protocol should be provided along with the kit.
16. The kits must be provided all reagents used for detection of animal virus or bacteria.
17. Absorbance reading of assay procedure must be read by any commercially available micro plate reader capable of reading at 450nm wavelength.
18. Each kit must be properly labeled and include: content per pack; special storage requirements; batch number; and date of manufacture and date of expiry & special storage requirements.
19. Should have been referenced in peer reviewed publications in indexed and good impact factor journals.
20. **All above details should be clearly mentioned in the technical bid only to be considered for evaluation.**
